Data Quality Report

Purpose of this report

The purpose of this report is to provide DAISEY users with a report to help troubleshoot common data entry issues. The report will highlight issues that could exclude caregivers and children from appearing in other reports.

What is counted in this report

Any caregiver or child in the KS MIECHV DAISEY initiative will be eligible for this report if they have a profile created after October 1, 2024, and within the selected reporting period.

Using Filters

Use the following filters to determine the data to review:

- * Start and End Date
- * Organization Name
- * County
- * Home Visitor
- * Caregiver Name (ID)
- * Child Name (ID)

Missing Enrollment Forms Dashboard

The Missing Enrollment Dashboard provides a view of all caregivers and children with profiles created after October 1, 2024, and within the reporting period with no Enrollment-Discharge forms. Caregivers and children without enrollment forms will not appear in the other KS MIECHV reports.

Clicking on the orange boxes will filter to only the applicable participants (Figure 2). You can click on multiple boxes to apply additional filters.

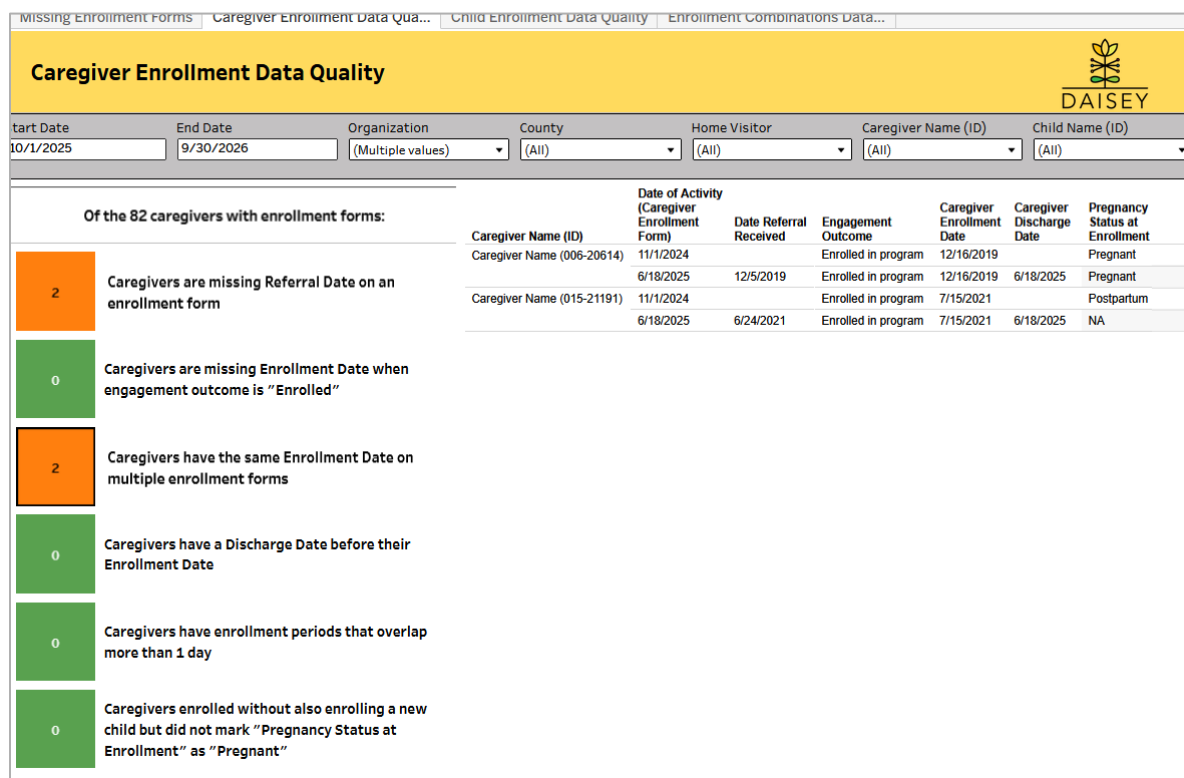

The Child Enrollment Data Quality Dashboard provides a view of all children with Enrollment-Discharge forms with enrollment and/or discharge dates within the reporting period who have one or more data quality issues that may exclude them from appearing correctly in other KS MIECHV reports.

Once filters are applied, the report will show all children with any of the data quality issues listed on the left side of the report. Clicking on the orange boxes will filter to only the applicable participants (Figure 4). You can click on multiple boxes to apply additional filters.

Enrollment Combination Data Quality Dashboard

The Enrollment Combinations Data Quality Dashboard provides a view of all caregiver and children combinations (one caregiver, one index child) where at least one has an enrollment date and are active within the reporting period who have one or more data quality issues that may exclude them from appearing correctly in other KS MIECHV reports.

Once filters are applied, the report will show all pairs of caregiver and index child with any of the data quality issues listed on the left side of the report. Clicking on the orange boxes will filter to only the applicable participants (Figure 4). You can click on multiple boxes to apply additional filters.
