Engagement Report

Guide Purpose

This guide provides technical information and additional program instructions for users accessing the KS MIECHV Engagement Report.

Report Purpose

The KS MIECHV Engagement Report allows the KS MIECHV State program managers, Supervisors, and Family Support Professionals to understand service data that is not captured on the mandated HRSA reports that support program monitoring. Data from the Caregiver Profile and Caregiver Enrollment-Discharge form is used to populate the report. Please see information about the specific dashboards to see how caregivers are included.

What is Counted in the Report

All Caregiver Enrollment-Discharge forms with enrollment and discharge dates occurring during the date range selected on the report. Some dashboards may only show caregivers if certain fields of the Caregiver Enrollment-Discharge form are completed. For example, the Participation and Enrollment Dashboard will only show caregivers with the “Date referral received” field completed.

Figure 1: Screenshot of Filtering Options

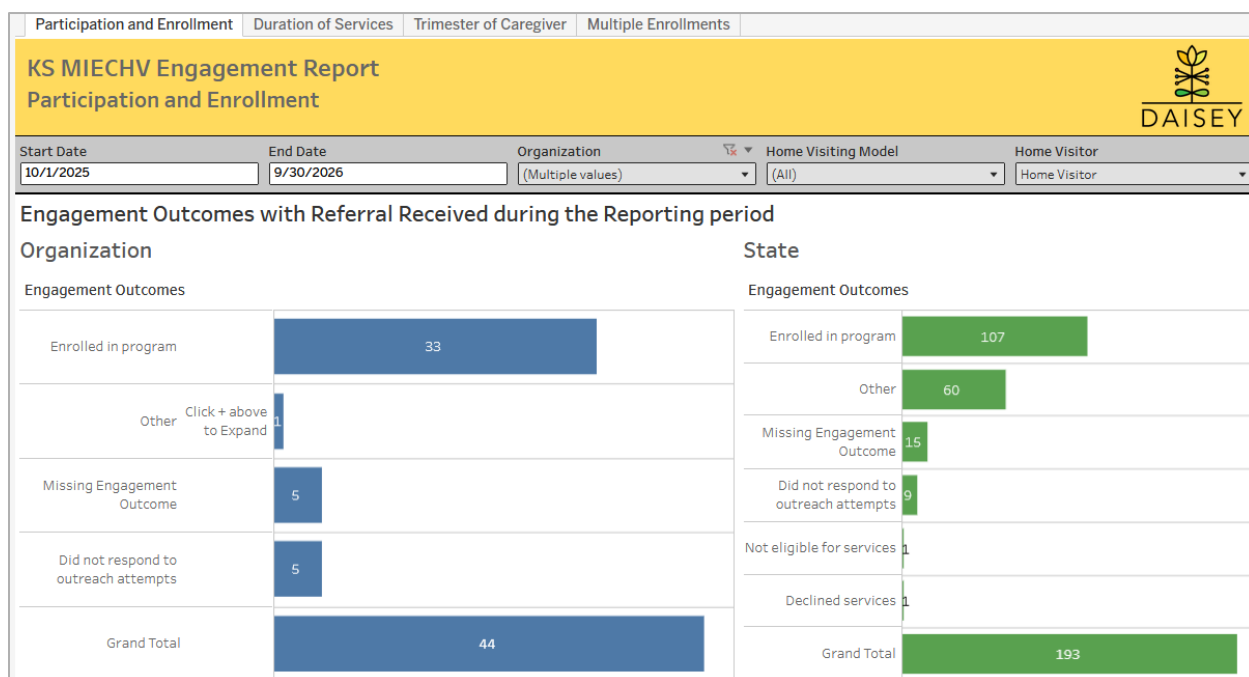

Participation and Enrollment Dashboard

The Participation and Enrollment dashboard is designed to provide DAISEY users with a snapshot of referral and enrollment information during the selected date range.

Once filters are selected, the left side of the report displays a stacked bar graph with a count of caregivers in the organization with the “Date referral received” field completed on the Caregiver Enrollment-Discharge form. The right side of the report displays a stacked bar graph with a count of all caregivers in Kansas MIECHV with the “Date referral received” field completed on the Caregiver Enrollment-Discharge form.

Duration of Services Dashboard

The Duration of Services dashboard is designed to provide a snapshot of the duration of services for caregivers in your organization. Once filters are selected, the report displays text showing the average time to enroll in your program for caregivers with a referral date, the average length between the enrollment date and today, and the average time between the enrollment date and discharge date.

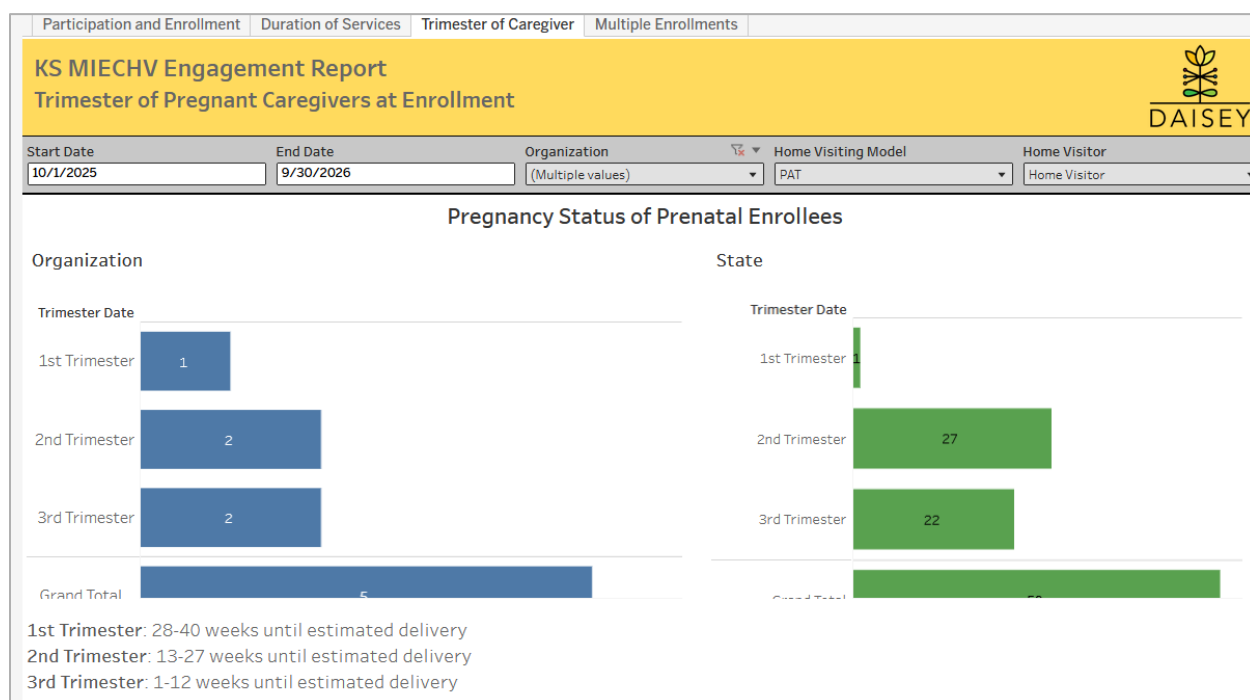
Figure 3: Screenshot of Duration of Services Dashboard

Trimester of Caregiver Dashboard

The Duration of Services dashboard is designed to provide a snapshot of how far into a pregnancy a caregiver is when they enroll in services. Once filters are selected, the report displays a stacked bar graph with the count of pregnancy status of prenatal enrollees by trimester. The date ranges for trimesters are listed below the bar graph on the report.

Multiple Enrollments Dashboard

The Multiple Enrollments Dashboard provides a view of caregivers who have more than one enrollment period during a reporting period. Once filters are selected, the report displays information from the Caregiver Enrollment-Discharge forms for all caregivers with multiple enrollments during the reporting period. A caregiver may have multiple enrollments because they discharged then re-enrolled in the program within the same reporting period.
